#### *Petone Technical Institute Notice 1977, Amendment No. 1*

PURSUANT to section 69 of the Education Act 1964, the Minister of Education hereby gives the following notice.

#### NOTICE

1. (a) This notice may be cited as the Petone Technical Institute Notice 1977, Amendment No. 1, and shall be read together and deemed part of the Petone Technical Institute Notice 1977\* (hereinafter referred to as the principal notice).

(b) This notice shall come into force on its date of publication in the *Gazette*.

2. Clause 3 (h) of the principal notice is hereby amended to read:

3 (h) "One member who shall represent the staff of the Petone Technical Institute and who shall be elected by permanent full-time tutors and permanent full-time ancillary staff employed by the council and who shall be a permanent full-time tutor employed by the council"

3. Clause 3 (i) of the principal notice is hereby amended to read:

3 (i) (i) "One member who shall be a student of the Petone Technical Institute and who shall be appointed by the Petone Technical Institute Students' Association for a term of office of 1 year"

3 (i) (ii) "The member appointed pursuant to subparagraph (i) of this paragraph shall hold office from the 1st day of February until the 31st day of January in the subsequent year, and if on that date the appointment of a successor has not been notified to the Council, that member shall continue to hold office until the date on which that appointment is notified".

4. Clause 4 (3) of the principal notice is hereby amended to read:

4 (3) Except in the case of a casual vacancy or as is provided in clause 3 (i) (ii) of this notice, every member shall hold office until the 31st day of August in the third year after the year of his appointment or election, and if on that date the appointment or election of his successor has not been notified to the council, he shall continue to hold office until the date on which the appointment or election is notified.
