

Oparara Survey District; thence by a right line across the Karamea-Kohaihai Road, to and along the northern boundary of the said part Section 15, the western boundary of part Section 33, Block V, Oparara Survey District, the western and north-eastern boundaries of Lot 1, D.P. 9631 and the eastern boundaries of the said part Section 33; thence generally south-easterly along the eastern boundary of a legal road (adjoining Sections 6, 5, 4, 3, 2, and 1, Block V, Oparara Survey District), the northern boundary of Crown land, Section 96, Block IX, Oparara Survey District, across a legal road and along the northern and eastern boundaries of Section 94, Block IX, Oparara Survey District;

Thence again generally south-easterly along the eastern boundary of Section 54, Block IX, Oparara Survey District, across a legal road and again along the eastern boundary of the said Section 54; thence again generally south-easterly along the northern boundary of Section 30, Block IX, Oparara Survey District, across a legal road, and again along the northern and eastern boundaries of the said Section 30, the northern boundary of Section 48, Block IX, Oparara Survey District and the northern and eastern boundaries of Section 49, Block IX, Oparara Survey District; thence by a right line across a legal road, the Oparara River and another legal road to the northern corner of the western portion of Section 65, Block IX, Oparara Survey District;

Thence again generally south-easterly along the north-western boundaries of the said Section 65, the north-eastern boundaries of Section 56, Block IX, Oparara Survey District, the north-eastern boundaries of part Section 86, Block IX, Oparara Survey District to a point on the northern bank of the Baker Creek; thence generally easterly along the northern bank of the said Baker Creek to a point in line with the western boundary of part Section 82, Block XIV, Oparara Survey District; thence by a right line across Baker Creek to and along the western boundary of the said part Section 82 (State Forest, *New Zealand Gazette*, 1947, p. 905); thence generally easterly along the northern boundaries of part Section 82, Block XIV, Oparara Survey District and part Section 78, Block XV, Oparara Survey District (both certificate of title 50/77), the western and southern boundaries of part Section 79, the southern and eastern boundaries of part Section 80, the north-eastern boundaries of Section 35, across a legal road, and again along the north-eastern boundary of the said Section 35, all Block XV, Oparara Survey District;

Thence again generally easterly along the western and northern boundaries of Section 22, Block XV, Oparara Survey District; the northern boundary of Section 25, across the end of a legal road, along the northern and eastern boundaries of Section 26, the northern boundaries of part Section 32, and Section 29, all Block XV, Oparara Survey District; thence generally south-westerly along the eastern boundary of the said Section 29 and that boundary produced to the centre of the Karamea River; thence continuing down the centre of the Karamea River to a point in line with the eastern boundary of Section 30, Block XV, Oparara Survey District; thence by a right line to and along the eastern boundary of the said Section 30, the southern boundary of Sections 30 and 27, across a legal road to and along the north-western boundary of Section 38, all of Block XV, Oparara Survey District;

Thence again generally south-westerly along the southern boundaries of legal road, the eastern boundary of Section 13, the eastern and southern boundaries of part Section 12 (certificate of title 55/215), the north-eastern and south-eastern boundaries of Section 11, the north-eastern boundary of Section 28 and the north-eastern, south-eastern, and south-western boundaries of Section 37, all of Block XV, Oparara Survey District; thence generally easterly along the eastern side of a legal road to a point in line with the southern boundary of Section 24, Block XV, Oparara Survey District; thence by a right line across the said legal road to and along the southern boundary of the said Section 24; thence again generally easterly along the south-western boundary of the said Section 24, the southern boundary of Section 23, Block XV, Oparara Survey District, the south-eastern and southern boundaries of Section 35, the southern and south-western boundaries of Section 34, the southern boundaries of Section 50 and part Sections 11 and 12, across a legal road and again along the southern boundary of the said part Section 12 and its production across the end of a legal road, all Block XIV, Oparara Survey District;

Thence by a right line to the southernmost corner of part Section 13 (certificate of title 67/161), Block XIV, Oparara Survey District; thence again generally easterly along the south-western boundaries of part Sections 13, 13A, and 14, the north-western boundary of the said part Section 14, the north-eastern boundaries of Section 57, the north-eastern and north-western boundaries of the northern portion of part Section 56, Block XIV, Oparara Survey District; thence generally southerly along the northern boundary of Section 86, the north-eastern and north-western boundaries of the southern portion of part Section 56, both Block XIV, Oparara Survey District, the western and southern boundaries of part Section 59, Block I, Otumahana Survey District and that boundary produced across a legal road to the centre of Granite Creek; thence along the centre

of the said Granite Creek to a point in line with the eastern boundary of part Section 4, Block I, Otumahana Survey District;

Thence by a right line to and along the eastern boundary of the said part Section 4 across the end of a legal road, again along the eastern boundary of the said part Section 4, the eastern boundary of Section 30, Block I, Otumahana Survey District and the eastern and southern boundaries of the said part Section 4 to the north-eastern corner of Section 11, Block I, Otumahana Survey District; thence again generally southerly along the north-eastern and southern boundaries of the said Section 11 across a legal road, again along the southern boundary of the said Section 11, the eastern side of Kongahu Swamp Road, the eastern boundary of Section 26, Block I, Kongahu Survey District and again along the eastern side of the said Kongahu Swamp Road to a point on the northern bank of Blackwater Creek; thence by a right line to and along the northern boundaries of Section 49, Block II, Kongahu Survey District, the northern boundary of Lot 1, D.P. 8788, across State Highway No. 67, along the northern boundary of part Section I, Block II, Kongahu Survey District and that boundary produced across a legal road to a point on the mean high water mark of the Tasman Sea; thence generally northerly along the mean high water mark of the Tasman Sea, all inlets, across the mouths of all rivers and streams of the Karamea Bight to the point of commencement;

Secondly, all that area in the Buller County containing 40 hectares, approximately, being Sections 104-110, Square 152 and Crown land in Block XIII, Oparara Survey District, being an island at the mouth of the Karamea River;

Thirdly, all that area in the Buller County containing 4.2492 hectares, approximately, being Sections 111 and 112, Square 152, situated in Block XIII, Oparara Survey District, being an island at the mouth of the Karamea River.

As the same are more particularly delineated on plan No. OPS 4/1/5D15, deposited in the National Headquarters of the New Zealand Fire Service at Wellington and thereon bordered red.

SIXTEENTH SCHEDULE

WAIMANGAROA FIRE DISTRICT

ALL that area in the Nelson Land District containing 7560 hectares, approximately, situated in the Buller County bounded by a line commencing at a point on the mean high water mark of the Tasman Sea being on the south-western boundary of the Granity Fire District hereinbefore described and proceeding generally south-easterly along that boundary to the southernmost corner of Section 10, Block VI, Ngakawau Survey District; thence by a right line to the centre of Jones Creek; thence generally south-easterly along the centre of the said Jones Creek to a point in line with the south-eastern boundary of Section 50, Block II, Kawatiri Survey District; thence by a right line across the end of a legal road to and along the south-eastern boundary of the said Section 50, Block II, Kawatiri Survey District; the south-eastern boundary of Section 53, across the end of a legal road and along the south-eastern boundary of Section 91 and its production to a point on the true right bank of Stony Creek, all of Block II, Kawatiri Survey District;

Thence generally south-easterly along the true right bank of Stony Creek to a point in line with the south-eastern boundary of Section 48, Block II, Kawatiri Survey District; thence by a right line to and along the said south-eastern boundary, along the south-western boundary of Section 48, the south-eastern and south-western boundaries of Section 88, all Block II, Kawatiri Survey District and the south-eastern boundary of part Lot 2, D.P. 2724 and its production across a legal road to a point on the true right bank of the Waimangaroa River; thence generally south-easterly along the true right bank of the said Waimangaroa River to a point in line with the northern boundary of Section 38, Block VI, Kawatiri Survey District; thence by a right line to and along the northern boundary of the said Section 38, the north-eastern boundaries of the said Section 38 to a point on the true right bank of the said Waimangaroa River;

Thence generally south-easterly along the said true right bank to a point on the eastern boundary of Block VI, Kawatiri Survey District; thence generally south-westerly along the eastern and southern boundaries of the said Block VI, Kawatiri Survey District, and the southern boundary of Block V, Kawatiri Survey District to a point on the true right bank of Myers Stream; thence generally north-westerly along the true right bank of the said Myers Stream to its confluence with Deadmans Creek; thence again generally north-westerly along the true right bank of the said Deadmans Creek to a point on the mean high water mark of the Tasman Sea; thence generally north-easterly along the mean high water mark of the Tasman Sea across the mouth of all rivers and streams to the point of commencement.
