

Australia - New Zealand Closer Economic Relations—Trade Agreement (ANZCERT)

THE Supplement to the *New Zealand Gazette*, of Thursday, 11 August detailed the way in which the balance of unallocated TEALs (published in the *New Zealand Gazette*, of 15 July 1983) where to be made available.
