

generally westerly and northerly along the southern and western boundaries of the said Section 2 and Section 9, Block XI, Upper Waitara Survey District, and the production of the last-mentioned boundary to the middle of the Waitara River;

Thence south-westerly generally down the middle of the Waitara River to a point in line with the western boundary of Section 1, Block X, Upper Waitara Survey District; thence northerly to and along the western boundary of that section, to and westerly along the northern boundary of Section 18, Block XIV, Upper Waitara Survey District, to the north-eastern side of the Mangapito Road; thence south-easterly along the north-eastern side of that road to a point in line with the western boundary of Section 6, Block XIII, Upper Waitara Survey District; thence southerly along a right line across Mangapito Road to and along that boundary and the western boundary of Section 9 to the northern boundary of Section 2 all Block XIII, Upper Waitara Survey District; thence westerly generally along the northern boundaries of Sections 2 and 1, Block XIII, aforesaid, and Sections 7, 6, and 5, Block XVI, Waitara Survey District, and the last-mentioned boundary produced to the western side of Mataro Road; thence northerly and westerly along that side of Mataro Road, to and westerly along the northern side of Taramoukou Road to the eastern boundary of Section 21, Block XV, Waitara Survey District; thence northerly along the eastern boundary of that section to and westerly along the northern boundaries of the said Section, and Section 20, Block XV, aforesaid, and the last-mentioned boundary produced to the middle of the Onaero River; thence westerly generally along the middle of that river to a point in line with the northern boundary of part Section 12, Block XV, Waitara Survey District; thence westerly to and along that boundary and the northern boundary of Lot 1, D.P. 12264, and the last-mentioned boundary produced to the western side of Otaraoa Road;

Thence southerly along that side to the south-eastern boundary of part Lot 7, D.P. 658; thence south-westerly along that boundary, the south-eastern boundary of Section 14, Block XIV, Waitara Survey District, and again the south-eastern boundary of the said part Lot 7, and the last-mentioned boundary produced to the middle of the Waitara River; thence north-westerly generally down the middle of that river to a point on the boundary of the Borough of Waitara due east of the confluence of the Mangahinau Stream with the Waitara River; thence south-easterly and northerly generally along the south-western and eastern boundaries of the Borough of Waitara as previously described to the sea coast; thence north-easterly generally along the sea coast to the point of commencement.

BOUNDARIES OF STRATFORD COUNTY

ALL that area in the Taranaki Land District bounded by a line commencing at the summit of Mount Egmont and proceeding easterly along a right line to the intersection of the west side of Forest Road and the Waipuku Stream; thence north-easterly generally down the middle of that stream to the middle of the Manganui River; thence eastern up the middle of that river to a point in line with the northern boundary of part Section 18, Block IX, Huiroa Survey District; thence easterly to and along that boundary and southerly along the eastern boundary of the said part Section 18 to the northern side of Croydon Road; thence generally easterly along the northern side of Croydon Road to the south-eastern corner of Section 11, Block X, Huiroa Survey District; thence northerly along the eastern boundary of the said Section 11 to the southern boundary of Section 14, Block X, Huiroa Survey District; thence easterly along the said southern boundary of Section 14 to the western side of the Mangaotea Road; thence southerly along the western side of that road to a point in line with the southern boundary of Section 20, Block X, Huiroa Survey District; thence along a right line across Mangaotea Road to and easterly along the southern boundary of the said Section 20 to its easternmost point; thence southerly and easterly along the western and southern boundaries of Section 26, Block X, Huiroa Survey District, to the Makara Road; thence northerly along the western side of the Makara Road to a point in line with the southern boundary of Lots 1 and 2, D.P. 5192;

Thence along a right line across Makara Road to and easterly along the southern boundary of the said Lots 1 and 2 and southerly along the eastern boundary of Lot 1, D.P. 6978, and the production of the last-mentioned boundary to the middle of the Makara Stream; thence easterly down the middle of the Makara and Makino Streams to a point in line with the eastern boundary of Lot 1, D.P. 7203; thence northerly to and along that boundary and its production to the middle of Makara Road; thence northerly generally along the middle of that road and Mana Road to a point in line with the north-western boundary of Section 3, Block XI, Huiroa Survey District; thence easterly to and along that boundary and easterly generally along the north-eastern boundaries of the said Section 3, to the northern boundary of Section 17, Block XI, Huiroa Survey District; thence easterly along that boundary and the northern boundary of Section 25, Block XII, Huiroa Survey District, and the production of the last-mentioned boundary across a road to the

middle of the Makino Stream; thence north-easterly generally down the middle of that stream to the middle of the Waitara River and easterly up the middle of that river to a point in line with the western boundary of Section 9, Block VIII, Huiroa Survey District; thence to and generally northerly and easterly along the western and northern boundaries of Sections 9 and 13, Block VIII, Huiroa Survey District, and south-easterly generally along the north-eastern boundary of Section 18, Block V, Ngatimaru Survey District, and its production to the middle of the Waitara River;

Thence north-easterly generally up the middle of that river to a point in line with the western boundary of Section 9, Block XI, Upper Waitara Survey District; thence southerly to and along the western boundary of the said Section 9 to and generally south-easterly along the south-western boundaries of that section and Section 2, Block XVI, Upper Waitara Survey District, to and generally northerly along the eastern boundaries of the said Section 2 and Section 8, Block XII, Upper Waitara Survey District, and the last-mentioned boundary produced across Mangare Road to its northern side; thence westerly along the northern side of Mangare Road to the eastern boundary of part Section 3, Block XII, Upper Waitara Survey District; thence northerly generally along the eastern boundary of that section and its production across Mangaowata Road to the middle of the Mangaowata Stream; thence easterly generally up the middle of that stream to a point in line with the eastern boundary of part Section 1, Block XII, Upper Waitara Survey District; thence northerly to and along the eastern boundary of that section to the southern boundary of part Section 4, Block VIII, Upper Waitara Survey District; thence generally easterly along the southern boundary of that section and generally easterly and northerly along the southern and eastern boundaries of Sections 5, 6, and 7, Block V, Pouatu Survey District, to the Makino North Road; thence along a right line across Makino North Road and Section 8, Block V, Pouatu Survey District, to the southernmost corner of Section 8, Block 1, Pouatu Survey District; thence generally northerly and westerly along the eastern and northern boundaries of the said Section 8 to the Moki Road;

Thence along a right line across Moki Road to the western boundary of Section 4, Block I, Pouatu Survey District; thence generally northerly along that boundary, the eastern boundary of Section 11, Block XIII, Waro Survey District, the eastern boundary of Section 3, Block XIII, aforesaid, the eastern boundary of Section 22, Block XIII, aforesaid, and again the eastern boundary of the said Section 3 to Rerekapa Road; thence along a right line across Rerekapa Road to the north-western boundary of Section 9, Block XIII, Waro Survey District; thence north-easterly and south-easterly along the north-western and south-eastern boundaries of the said Section 9 to and easterly along the northern boundary of Section 23, Block XIII, Waro Survey District to the north-western boundary of Section 57, Block XIV, Waro Survey District; thence north-easterly and south-easterly along the north-western and north-eastern boundaries of the said Section 57 to the western side of Okau Road; thence northerly along that side to a point in line with the northern boundary of Section 56, Block XIV, Waro Survey District; thence along a right line across Okau Road to and generally easterly along that boundary and the northern boundaries of Section 63, Block XIV, aforesaid, and Sections 18 and 19, Block X, aforesaid, to the western boundary of Section 20, Block X, aforesaid;

Thence generally northerly along that boundary and the western boundaries of Section 21, Block X, aforesaid, and Section 5, Block XI, Waro Survey District, to a point on the western boundary of the Section 5 in line with the northern boundary of Block XV, Waro Survey District; thence easterly along a right line across the said Section 5 to and along the northern boundaries of Blocks XV and XVI, Waro Survey District, to the confiscation line, and south-westerly along that line to the eastern boundary of Block XV, Waro Survey District; thence southerly along the eastern boundary of the said Block XV and its extension to the thirty-ninth parallel of south latitude, and easterly along that parallel to the middle of the Heao Stream; thence southerly generally down the middle of that stream to a point in line with the northern boundary of Section 2, Block IX, Heao Survey District; thence easterly along a right line to and across Heao Road to and generally easterly along the northern boundary of the said Section 2 and the northern boundary of Section 5, Block X, Heao Survey District, to the western boundary of Maraekowhai A. 3B 1; thence northerly along that boundary and the western boundary of Maraekowhai A. 3B 2 to and easterly along the northerly boundary of the said Maraekowhai A. 3B 2 and its production to the middle of the Wanganui River; thence south-westerly generally down the middle of that river to its southernmost intersection with a right line between Trig. Station B, Mount Humphries and the confluence of the Wanganui and Tangarakau Rivers; thence south-westerly along that right line to the said Trig. Station B, Mount Humphries;

Thence southerly along the western watershed of the Wanganui River to a point in line with the northern boundary of Section 2, Block XI, Taurakawa Survey District; thence westerly to and along that boundary and a right line across a road (bisected by the Omaru Stream), to and along the northern boundary of Section 1, Block XI, aforesaid, the northern boundary of Section 1, Block X, aforesaid, and a right line across Puteore Road, to and along the northern
