2.10.1 Class 1 war pensioners: Page 2213

Omit this clause and substitute:

2.10.1 Class 1 war pensioners: On presentation of the appropriate free pass issued by the Department of Social Welfare, Class 1 war pensioners, and their accompanying attendants if the free pass is so endorsed, are entitled to travel free except that charges for rail ferry passenger tickets are to be debited to the Department of Social Welfare.

2.14.6 Refund or re-issue entitlement: Page 2214

Omit:

Less than 7 days prior to travel date on ticket but more than 30 minutes prior to departure time shown on ticket.

Omit:

Later than 30 minutes prior to departure time shown on the ticket but within 3 months of the date of travel shown on the ticket.

Insert:

Less than 7 days prior to travel date on ticket but in the case of a rail ticket more than 30 minutes prior to departure time shown or in the case of a rail ferry ticket more than 30 minutes prior to reporting time shown.

Insert:

Later than 30 minutes prior to departure time shown in the case of a rail ticket or later than 30 minutes prior to reporting time shown in the case of a rail ferry ticket but in either case within 3 months after the date of travel.

2.15 Lost tickets

Insert after clause 2.15.4 a new clause 2.15.5

2.15.5 Lost rail ferry passenger tickets: When a rail ferry ticket is issued for passenger travel only, it will not be refundable in the event of loss.
