Thence south-easterly along the south-western boundary of that section to the north-western side of an unnamed road; thence generally north-easterly along the generally north-western side of that road to a point in line with the northern boundary of Section 18, Block VII, Strath Taieri Survey District; thence easterly to and along the northern boundary of that section to the western side of an unnamed road; thence southerly, south-easterly and easterly along the western, south-western and southern sides of that road and the production of the last-mentioned side to the eastern side of Macraes Road; thence generally southerly along the generally eastern sides of Macraes Road and Moonlight Road to the westernmost corner of Section 19, Block VI, Budle Survey District; thence generally easterly along the generally and the production of the last-mentioned side to the eastern side of Macraes Road; thence generally northern boundaries of that section and Sections 18 and 22, Block VI, aforesaid, and the production of the last-mentioned boundary to the westernmost corner of Section 26, Block VI, aforesaid;
