

and north-westerly along the generally north-western and north-eastern sides of that road to the south-eastern corner of Lot 1, D.P. 7911; thence generally northerly along the generally eastern boundary of that Lot to its northernmost corner; thence north-easterly along the production of the north-western boundary of the said Lot 1, to its intersection with a line parallel to and distant 50.29 metres north-eastward from the original north-eastern side of Reservoir Road; thence north-westerly along that line to the southernmost corner of part Lot 2, D.P. 1058;

Thence north-westerly along the south-western boundary of that part lot, the north-eastern boundaries of Lots 8, 7, and 6, D.P. 2095 and the production of the last-mentioned boundary to and along the north-eastern boundaries of Lots 4, 3, 2, and 1, D.P. 2095, to the south-eastern boundary of Lot 1, D.P. 18267; thence north-easterly along the south-eastern boundaries of that lot and Lot 2, D.P. 18267 and north-westerly along the north-eastern boundary of Lot 2, D.P. 18267, to the easternmost corner of Lot 4, D.P. 1058; thence north-westerly, south-westerly, south-easterly, and south-westerly along the north-eastern, north-western, south-western, and north-western boundaries of Lot 4, D.P. 1058, to the intersection of the last-mentioned boundary with a line parallel to and distant 50.29 metres north-eastward from the north-eastern side of Reservoir Road;

Thence north-westerly along that line to the south-eastern boundary of the land comprised in certificate of title 75/153; thence north-easterly and north-westerly along the south-eastern and north-eastern boundaries of the land comprised in that certificate of title to the northernmost corner of the said land; thence north-easterly along a right line to the southernmost corner of Section 2 of 79, Block VII, North Harbour and Blueskin Survey District; thence north-westerly along the south-western boundary of that section to its intersection with the production of a line parallel to and distant 50.29 metres north-westward from the north-western boundary of Section 125R, Block VII, North Harbour and Blueskin Survey District;

Thence south-westerly to and along that line and its production to the south-western boundary of Section 1 of 85, Block VII, aforesaid; thence south-easterly along the south-western boundary of that section and the production of that boundary to and along the south-western boundary of Sawyers Bay Survey District to the northernmost corner of Lot 1, D.P. 1759; thence south-easterly along the north-eastern boundary of that lot, and its production to the middle of Brick Hill Road; thence generally south-westerly along the middle of that road to a point in line with the south-eastern boundary of part Lot B, D.P. 1124;

Thence north-easterly to and along the south-eastern boundary of that part lot to the south-western boundary of Sawyers Bay Survey District; thence south-easterly along that boundary to the original mean high water mark of the Otago Harbour; thence generally south-easterly along that mean high water mark to a point on the southern boundary of Section 23, Sawyers Bay Survey District, at Kilgour's Point, at the intersection of the mean high water mark with a line bearing 288°, distant 110.64 metres from the nearest angle on the south-eastern boundary of the area vested in the Otago Harbour Board by the Otago Harbour Board Land Vesting Act 1910;

Thence along that line bearing 108° to the nearest angle on the said south-eastern boundary; thence generally south-westerly along the generally south-eastern boundary of that area, vested in the Otago Harbour Board, to a point in line with the south-western boundary of part Section 13, Upper Harbour West Survey District; thence north-westerly to and along the south-western boundary of that part section and its production to the south-eastern boundary of Block IX, North Harbour and Blueskin Survey District; thence north-easterly along that block boundary to the southernmost corner of Section 63, Block IX, aforesaid;

Thence north-westerly along the south-western boundaries of that section and part Section 2 of 5 and the production of the last-mentioned boundary to the intersection of that boundary and a right line between Trig E, Block IX, aforesaid, and the northernmost corner of part Section 2 of 5, aforesaid; thence north-easterly along that right line to the northernmost corner of the said part section; thence north-westerly and north-easterly along the south-western and north-western boundaries of Section 2 of 4, Block IX, aforesaid, to a point in line with the south-western boundary of Lot 1, D.P. 5250;

Thence north-westerly to and along the south-western boundary of that lot and its production to the south-eastern boundary of Lot 1, Block II, D.P. 253; thence north-easterly along that south-eastern boundary to the easternmost corner of Lot 1, Block II, aforesaid; thence north-westerly along the north-eastern boundaries of the said Lot 1, Lots 4, 5, 6, and 7, Block II, D.P. 253, and the production of the last-mentioned boundary to the north-western boundary of Section 369R, Block VII, North Harbour and Blueskin Survey District; thence north-easterly along the north-western boundary of that section to the easternmost corner of Lot 8, Block II, D.P. 253;

Thence north-westerly along the north-eastern boundaries of that lot and Lots 9, 10, and 11, Block II, D.P. 253, and the production of the last-mentioned boundary to and along the north-eastern

boundary (and its production across an unnamed road) of Section 2, Block VIII, North Harbour and Blueskin Survey District, to the northernmost corner of that section; thence south-westerly and north-westerly along the south-eastern and south-western boundaries of Section 48, Block VIII, aforesaid, to the westernmost corner of that section; thence south-westerly and north-westerly along the south-eastern and south-western boundaries (and the productions those boundaries across an unnamed road) of Section 62, Block VIII, aforesaid, to the westernmost corner of that section;

Thence south-westerly along the north-western boundary of Section 61, Block VIII, North Harbour and Blueskin Survey District, to a point in line with the south-western boundary of the said Section 61; thence south-easterly along the production of the south-western boundary of that section to the middle of Cowan Road; thence south-westerly along the middle of Cowan Road to a point in line with the south-western boundary of Section 12, Block VIII, aforesaid; thence north-westerly along a right line to the southernmost corner of that section; thence south-westerly along the north-western side of Cowan Road and the production of that roadside to and along the south-eastern boundary of Section 4, Block VIII, aforesaid, to the southernmost corner of that section;

Thence north-westerly along the south-western boundary of Section 4, aforesaid, to a point due east of the northernmost corner of Section 83, Block V, Dunedin and East Taieri Survey District; thence due west to the northernmost corner of the said Section 83; thence south-westerly along the north-western boundaries of Sections 83 and 82 and Lot 2, D.P. 5108, to the westernmost corner of the said Lot 2; thence south-easterly along the south-western boundary of Lot 2, D.P. 5108, and its production to the right bank of the water of Leith; thence generally southerly along that right bank to a point due east of the southernmost corner of Section 73, Block V, aforesaid, thence due west to the southernmost corner of that Section 73;

Thence north-westerly along the south-western side of Section 73, aforesaid, to the south-eastern side of Finnerty Road; thence south-westerly and north-westerly along the south-eastern and south-western sides of that road to the south-eastern boundary of Lot 1, D.P. 7092; thence south-westerly and north-westerly along the south-eastern and south-western boundaries of that lot to the south-eastern side of Finnerty Road; thence north-westerly along a right line to the southernmost corner of Lot 2, D.P. 7092; thence north-westerly along the south-western boundary of that lot to the easternmost corner of Section 53, Block V, Dunedin and East Taieri Survey District; thence south-westerly along the south-eastern boundaries of Sections 53, 1 of 52, 51, Block V, aforesaid, and Lot 21, D.P. 1209, to the southernmost corner of the said Lot 21;

Thence north-westerly along the south-western boundary of Lot 21, D.P. 1209 to a point in line with the north-western boundary of Lot 2, D.P. 12395; thence south-westerly to and along the north-western boundary of that Lot 2 and its production to the north-eastern boundary of Section 61, Block V, aforesaid; thence south-easterly along the north-eastern boundary of that section and its production to the north-western boundary of Wakari Survey District; thence south-westerly and north-westerly along the north-western and north-eastern boundaries of that survey district to the easternmost corner of part Section 31, Wakari Survey District;

Thence south-westerly, north-westerly, and south-westerly along the south-eastern, south-western, and south-eastern boundaries of that part Section 31 to a point in line with the south-western boundary of part Section 32, Wakari Survey District; thence south-easterly to and along that north-eastern boundary to the northernmost corner of part Section 21, Wakari Survey District; thence south-westerly and south-easterly along the north-western and south-western boundaries of that part Section 21 to the northernmost corner of Section 5, Block X, Dunedin and East Taieri Survey District; thence south-westerly along the north-western boundary of that Section 5 and its production to the south-western side of Dalziel Road; thence south-easterly and south-westerly along the south-western and north-western sides of that road to a point in line with the north-eastern side of Sanda Road;

Thence south-easterly and easterly along the north-eastern and northern sides of Sanda Road to a point in line with the eastern boundary of Section 57, Block VI, Dunedin and East Taieri Survey District; thence southerly to and along that boundary and westerly along the southern boundary of that Section 57 to the easternmost corner of Section 84, Block VI, aforesaid; thence south-westerly along the south-eastern boundary of that section to the north-eastern boundary of Section 2 of 49, Block VI, aforesaid; thence south-easterly along the north-eastern boundaries of that section and Section 1 of 49 to the easternmost corner of the last-mentioned section; thence south-westerly along the south-eastern boundary of Block VI, Dunedin and East Taieri Survey District, to its intersection with the original middle of Townleys Road; thence generally north-westerly along the original middle of that road and its production to the middle of Reservoir Road;

Thence generally south-westerly along the middle of that road and Boundary Road and the production of the last-mentioned road to the middle of Gordon Street; thence southerly along the middle
