Submissions should include a reference to the identification reference, application number, Tariff Item, and description of goods concerned and be supported by information as to:

- The range of equivalent goods manufactured locally;
- The proportion of New Zealand and imported material used in manufacture;
- Present and potential output; and
- Details of factory cost in terms of materials, labour, overhead, etc.
