The Bill proposes to make provision relating to the grounds on which enrolment might be refused at an integrated school established by integration agreement between the Minister of Education and the Dilworth Trust Board and to generally empower the Dilworth Trust Board to enter into an integration agreement and to remove any obligation of the Dilworth Trust Board to solicit and approve applications in respect of boys resident in the Ulster Province of Northern Ireland to be selected and maintained as pupils of Dilworth
