NOTICE

1. This notice may be cited as the Mosgiel Borough—Silverpeaks County Boundaries Definition Notice 1983.

2. The boundaries of Mosgiel Borough and Silverpeaks County are hereby defined as set out in the Schedules hereto, those boundaries having been altered by Order in Council published in the *New Zealand Gazette*, 4 November 1982, No. 128, page 3608 and which came into force on 1 April 1983.

FIRST SCHEDULE

Thence north-westerly along the south-western boundaries of Lots 2 and 3, D.P. 10872, Lot 3, D.P. 18406, Lot 4, D.P. 7572 and Lot 2, D.P. 16408, to the westernmost corner of the last-mentioned lot; thence north-easterly along the north-western boundary of Lot 2, D.P. 16408, to the southernmost corner of Lot 2, D.P. 10404; thence north-westerly along the south-western boundaries of Lot 2, D.P. 10404, Lot 1, D.P. 10036 and Lot 1, D.P. 15155 and the production of the last-mentioned boundary to the north-western side of Gladstone Road; thence north-easterly along the north-western side of Gladstone Road to a point in line with the north-eastern boundary of part Section 3, Block III, East Taieri Survey District; thence north-westerly to and along the north-eastern boundaries of that section
