(2) Any co-operated member shall hold office during the pleasure of the Board for a period not exceeding 2 years, but may be re-appointed.

(3) If any appointed member dies, or resigns his office by writing under his hand addressed to the Board or the Chairman or the Director thereof, or is absent without leave from the meetings of the Board for 3 consecutive meetings, or while holding office becomes for any reason ineligible to remain a member, the casual vacancy so created shall be filled as soon as practicable thereafter by the appointment of a member in the manner in which the vacating member was appointed, and the member appointed to fill the vacancy shall hold office for the residue of the term of office of the member whom he replaces.

(4) Unless he sooner vacates his office every appointed member of the Board shall continue in office until his successor comes into office.

(5) The powers of the Board shall not be affected by any vacancy in the membership thereof.

4. (1) A deputy member may be appointed in the same manner as an appointed member, to be the deputy of that member and act in the event of the absence of that member from any meeting of the Board.

(2) While any person is acting pursuant to subclause (1) of this clause he shall be deemed to be a full member of the Board. The fact that any person so acts shall be sufficient evidence of his authority to do so.

5. The Board established by this notice is hereby declared to be the same Building Industry Training Board established by the Building Industry Training Board Notice 1980\* and in existence immediately before the commencement of this *Gazette* notice.

6. The Building Industry Training Board Notice 1980 is hereby revoked.
