PURSUANT to section 27 of the Agricultural Pests Destruction Act 1967, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. (i) This order may be cited as the East Waikato Pest Destruction District Abolition Order 1983.

(ii) This order shall come into force on the 8th day of October 1983.

2. The East Waikato Pest Destruction District, which was constituted by Order in Council on the 15th day of March 1971, and amended by Order in Council on the 2nd day of February 1981, is hereby abolished.

3. The assets and liabilities of the Board, including any real or personal property, are hereby transferred to the Board of the Matamata County Pest Destruction District.

PURSUANT to the Forest and Rural Fires Act 1977, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. This order may be cited as the Waitakere Rural Fire District Order 1976, Amendment No. 1, and shall be read together with and deemed part of the order constituting the Waitakere Rural Fire District Order made on the 8th day of November 1976* (hereinafter referred to as the principal order).

2. This order shall come into force from the date of its notification in the *New Zealand Gazette*.

3. The principal order is hereby amended by revoking the Schedule thereto and substituting the Schedule hereto.
