

## SCHEDULE

ALL that area in the North Auckland Land District, City of Waitemata, bounded by a line commencing Block I, Waitakere Survey District at the intersection of the line of mean high water of the Tasman Sea and the middle of the Waitakere River, and proceeding north-easterly, generally, along the north-western boundary of the City of Waitemata as defined by *New Zealand Gazette*, No. 78, 1977, p. 2026, to its intersection with the centreline of Nelson Road produced at the junction with Taupaki Road, thence to and south-easterly along the middle of the aforesaid road to and south-easterly along the middle of Red Hills Road to a point in line with the middle of Birdwood Road, thence by a right line south-easterly to the northernmost corner of the Massey Primary School, thence southerly, generally, along the western boundary of the Auckland Metropolitan Drainage District's Inner Area as defined by *New Zealand Gazette* at 1 September 1983, to the southernmost corner of Lot 55, D.P. 20226, thence south-easterly by a right line to the northernmost corner of Lot 1, D.P. 39183, thence south-westerly, generally, along the south-eastern boundary of the Auckland Regional Authority's Water Supply Reserve as defined at 1 September 1983, to a point on the north-western side of Huia Road in line with the south-western boundary of Lot 1101, D.P. 39700, thence across Scenic Drive to the westernmost corner of the aforesaid Lot 1101, and southerly, generally, along the eastern boundaries of part Allotments 42, 35, and SE 35 of Waikomiti Parish to the lastmentioned allotments junction with the line of mean high water on the Manukau Harbour, thence south-westerly, generally, along the said line of mean high water to and northerly, generally, along the line of mean high water of the Tasman Sea to the point of commencement.
