  - (a) That Fletcher Challenge Ltd. deliver to the Registrar of Companies at Wellington within 21 days of being issued two copies of the Preliminary Offering Prospectus, and the Final Offering Prospectus issued in connection with the raising of the loan.
    (b) That the Registrar of Companies is satisfied that the copies

(b) That the Registrar of Companies is satisfied that the copies of the Preliminary Offering Prospectus are not materially different from the draft Preliminary Offering Prospectus

previously delivered to him.
(c) That Fletcher Challenge Limited:

(i) Enter into a trust deed with The Law Debenture Corporation p.l.c. of London whereby the Law Debenture Corporation p.l.c. agrees to act as trustee for the bondholders; and

(ii) Deliver to the Registrar of Companies at Wellington within 21 days of its execution two copies of that trust
