The licence hereby conferred is subject to compliance by the licensee with the Electrical Supply Regulations 1976, the Electrical Wiring Regulations 1976, and with all regulations made in amendment thereof, or in substitution therefor, except in so far as they may be inconsistent with the provisions of this licence.

4. The systems of supply shall be described in paragraphs (a), (b), (c), (d), (e), (f), and (j) of regulation 15 of the Electrical Supply Regulations 1976. The system of supply authorised under paragraph (j) aforesaid shall be a single-conductor earth-return system of 11 000 volts between conductor and earth, and the use thereof shall be subject to such terms and conditions as are from Division of the Ministry of Energy.

5. This temporary licence, issued under section 20A (1) of the Electricity Act 1968, shall be in force for a period beginning on the 1st day of April 1983 and ending with the 31st day of March 1985 or the earlier issue of a licence under section 20 of the Electricity Act 1968.
