2. Any local authority may in respect of any such money borrowed by it, issue stock or debentures at a discount provided yield which would exceed by more than 1 percent per annum the maximum interest rate as determined by the Board applicable for the term of the loan.

3. All sanctions to which this general determination applies shall be varied accordingly.
