S. 379; thence generally south-westerly along those northern boundaries to and along the middle of Minchin Crescent, Beerescourt Road, Portal Crescent, Vercoe Road, Te Rapa Road, Forest Lake Road, Ellicott Road, and Newcastle Road to a point in line with the north-eastern boundary of Lot 6, D.P.
