Electric Lines Licence

I, William Francis Birch, Minister of Energy, acting pursuant to section 21 of the Electricity Act 1968, hereby licence Albert Whipp of Stewart Island, hereinafter referred to as "the licensee", to lay, construct, put up, place, and use the electric lines described in the Schedule hereto. This licence is issued subject to the following conditions:

CONDITIONS

1. This licence may be cited as the Albert Whipp Lines Licence 1983.

2. The conditions directed to be implied in all licences by regulation 10 of the Electrical Supply Regulations 1976, shall be incorporated herein and shall form part of this licence, except insofar as they may be inconsistent with the provisions of this licence.

3. This licence is subject to compliance by the licensee with the Electrical Supply Regulations 1976, the Electrical Wiring Regulations 1976, and all regulations made in amendment of or in substitution for any of those regulations, except insofar as they may be inconsistent with the provisions of this licence.

4. The systems of supply shall be as described in paragraph (d) of regulation 15 of the Electrical Supply Regulations 1976.

5. This licence shall come into force on the 1st day of July 1983 and shall continue in force for a period of 21 years from that date unless it is sooner lawfully determined.

LINES for the supply of electrical energy by the system of supply hereinbefore described, commencing from a generator situated in Lot 7, and proceeding in a north-westerly direction to the licensee's house situated in Lot 6.
