

(d) All money received by the Authority in the performance or exercise of the functions, duties, or powers conferred on it by this order in respect of the foreshore, lakeshore, lakebed, riverbed, and waters to which this order applies, shall, after the deduction of any expenditure incurred by the Authority in the performance or exercise of these functions, duties or powers, be applied to the construction, repair, or improvement of facilities in respect of that foreshore, lakeshore, lakebed, riverbed, or those waters, and not otherwise.

**6. Powers of Authority**—Subject to section 8A of the Act, the Authority may, in respect of the foreshore, lakeshore, lakebed, riverbed and waters to which this order applies—

- (a) By bylaw, do anything which a Harbour Board may do by bylaw under section 232 of the Act;
- (b) Appoint harbourmasters and other officers and define or limit their powers and duties.

**7. Procedure for making bylaws**—Bylaws made by the Authority pursuant to sections 8A and 165 of the Act shall be made in the manner prescribed under section 232A (1) (ca) of the Act.

**8. Revocations**—The following orders are hereby revoked:

- (a) The Lake Wanaka Order 1966\*
- (b) The Lakes District Foreshore, Lake Shore, Lake Bed, River Bed and Waters Control Order 1980†
- (c) The Lakes District Foreshore, Lake Shore, Lake Bed, River Bed and Waters Control Order 1980, Amendment No. 1.

PURSUANT to the Forest and Rural Fires Act 1977, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

1. This order may be cited as the Waitane Rural Fire District Order 1951, Amendment No. 3, and shall be read together with and deemed part of the order constituting the Waitane Rural Fire District Order made on the 17th day of April 1951\* (hereinafter referred to as the principal order).

2. This order shall come into force from the date of its notification in the *New Zealand Gazette*.

3. The principal order is hereby amended by revoking the Schedule thereto and substituting the Schedule hereto.

#### SCHEDULE

##### SOUTHLAND LAND DISTRICT—SOUTHLAND COUNTY

ALL THAT area in the Southland Land District, Southland County, containing approximately 3200 hectares, situated in Blocks I, II, and VIII, Lindhurst Hundred and Blocks V, VII, and X, Waimumu Hundred and bounded generally as follows:

Towards the west by Sections 38, 39, 37, 40, and 47, Block IV, Waimumu Hundred; towards the north by Section 48, Block IV, Waimumu Hundred and Sections 49 and 67, Block V, Waimumu Hundred; towards the west by Section 67 (aforesaid); towards the north-west by the north-western side of a public road; towards the north-east by the eastern side of a public road (aforesaid) and by Section 58, Block V, Waimumu Hundred; towards the north-west by Sections 58 (aforesaid), 59, 60, 61, and 62, Block V, Waimumu Hundred; towards the north-east by the north-eastern side of a public road; towards the east generally by Lot 1, D.P. 3906 and Lot 46 on Land Transfer Plan 177 (Southland Land Registry), and by the eastern side of Miller Road; towards the south by the southern side of the Winton-Gore Main Highway; towards the west by Sections 19 and 18, Block I, Lindhurst Hundred; towards the south by Section 18 (aforesaid) and 17, Block I, Lindhurst Hundred; towards the west by Section 55, Block I, Lindhurst Hundred; towards the north-west by the north-western side of a public road; towards the west generally by Section 56c, Block I, Lindhurst Hundred; towards the south by Section 56c (aforesaid) to the point of commencement.

The same is more particularly delineated on Plan Number F 45/3, deposited in the Head Office of the New Zealand Forest Service at Wellington.
