S. 2091; thence southerly, westerly and northerly along the eastern, southern and western boundaries of Lot 1, D.P. S. 2091 to a point in line with the northern side of Merrick Road;

Thence north-westerly along the north-eastern and northern sides of Merrick Road, and across its intersection with Edward Avenue to the intersection of Merrick Road with Gasson Lane;

Thence northerly along the eastern side of Gasson Lane to a point in line with the northern side of Melville Road; thence to and south-westerly along the generally north-western side of Melville Road to its intersection with Belk Road; thence north-westerly along the north-eastern side of Belk Road to a point in line with the northern side of Griffin Road; thence to and south-westerly, north-westerly, and generally northerly along the north-western, north-eastern and generally south-eastern sides of Griffin Road to the intersection with Allotment 806, Te Papa Parish as shown on S.O. 50760; thence westerly along the southern boundary of Allotment 806 to the north-eastern corner of Allotment 173, Te Papa Parish; thence south-westerly along the northern, and north-western boundaries of the said Allotment 173 to the Omanawa Stream; thence by a right line across the Omanawa Stream to the easternmost corner of Allotment 726, Te Papa Parish;

Thence generally south-westerly along the generally eastern boundaries of Allotment 726 to a point in line with the northern boundary of part Allotment 151, Te Papa Parish; thence to and westerly along the northern boundaries of part Allotments 151 and 150 and southerly along the western boundary of the said part Allotment 150 to a point in line with the northern boundary of Lot 1, D.P. S. 26430; thence to and westerly along that boundary and its production to right bank of the Wairoa River; thence down the right bank of the said river to a point on the north-western boundary of part Allotment 86, Te Papa Parish and across from the left bank of the Ohourere Stream; thence to and along the left bank of the Ohourere Stream to its intersection with Crawford Road;

Thence northerly along the eastern side of Crawford Road, to and westerly along the north-eastern side of Junction Road to and westerly along the northern side of Minden Road to the intersection with an unnamed road bisecting part Section 7, Block VIII, Tauranga Survey District; thence northerly along the eastern side of the unnamed road to a point being the south-western corner of Section 27, Block VIII, Tauranga Survey District, then northerly along the western boundary of Section 27 aforesaid and the last-mentioned boundary produced to the northern side of Munro Road; thence easterly along that northern side and northerly along the eastern boundary of Lot 1, D.P. S. 11413 and the last-mentioned boundary produced to a point on the southern boundary of Lot 2, D.P. S. 9634;

Thence north-easterly along the northern side of Snodgrass Road to the southern side of an unnamed road which forms the north-eastern boundary of Lot 1, D.P. S. 5426; thence north-westerly along that southern side to the shore of the Tauranga Harbour; thence in a generally north-easterly direction along that shore of Tauranga Harbour to Mount Maunganui; thence in a south-easterly direction along the Bay of Plenty coast to the point of commencement. As the same is more particularly delineated on plan number O.P. S. 4/1/2B01 and deposited in the National Headquarters of the New Zealand Fire Service at Wellington and thereon bordered red.
