Tauranga Fire District Notice 1984

PURSUANT to section 26 of the Fire Service Act 1975, the New Zealand Fire Service Commission gives the following notice.

NOTICE

Title and Commencement—(1) This notice may be cited as the Tauranga Fire District Notice 1984.

(2) This notice shall come into effect on the 1st day of October 1984.

(3) The Tauranga Fire District declared to be a fire district by Section 26 (1) of the Fire Service Act 1975 is hereby abolished.

(4) The boundaries of the Tauranga Fire District shall be as defined in the following Schedule.

SCHEDULE

ALL that area in the Tauranga County bounded by a line commencing at a point on the Bay of Plenty coast being the northern corner of Tumu Kaituna 14 Block, situated in Block V, Te Tumu S.D., and proceeding southerly along the western boundaries of Tumu Kaituna 14 Block and part Lot 1, D.P. 16773 to its intersection with Bell Road; thence generally north-westerly along the generally northern sides of Bell Road and its production to the eastern boundary of part Section 10, Block III, Te Tumu Survey District; thence generally southerly along the generally western side of State Highway No. 2 to the south-eastern corner of part Lot 1, D.P. 15409, thence generally westerly along the generally southern boundaries of part Lot 1, D.P. 15409, part Lot 2, D.P. 28204 and part Lot 2, D.P. 24699 to its westernmost corner;

Thence by a right line across Reid Road to the south-eastern corner of part Section 19, Block III, Te Tumu S.D.; thence generally westerly along the western side of Reid Road; and the generally northern side of Upper Papamoa Road and that roadside produced to intersect the western side of Waitao Road; thence generally southerly and westerly along the generally western side of Waitao Road and the northern and western sides of Garrett Road to the southern most point of Lot 1, D.P. S. 16104; thence westerly along the north-eastern, eastern and north-western boundaries of Section 24, Block IV, Otanewainuku Survey District; and the north-eastern boundaries of Section 7 and Section 6, Block IV, Otanewainuku Survey District and a production of that boundary to the centre of the Waitao Stream; thence down the centre of the Waitao Stream to a point in line with the north-eastern corner of Lot 2, D.P. S. 29669;

Thence westerly to and along the generally northern boundaries of Lot 2, D.P. S. 29669 and Lot 1, D.P. S. 9528 to Kaitemako Road; thence by a right line across the said road to the north-eastern corner of Lot 1, D.P. S. 23564; thence generally south-westerly along the northern and western boundaries of the said Lot 1 to the north-eastern corner of Lot 2, D.P. S. 29118; thence south-westerly along the northern boundary of the said Lot 2 to its intersection with Rowe Road; thence north-westerly along the north-eastern side of Rowe Road and its production to the western side of Ohauti Road; thence generally south-westerly along the generally north-western
