(a) That portion of the Clutha River lying between a point indicated by a landmark, approximately 600 metres from the outlet of Lake Wanaka, and a point indicated by a landmark, approximately 600 metres above the bridge at Albert Town; (b) The Nevis River; (c) All rivers and streams flowing into Lake Wakatipu, except the Dart River and the Rees River and the tributaries of the Dart and Rees Rivers; (d) The Upukerora River; (e) The Eglinton River.	Natural fly, or artificial fly.
4. All other waters within the district.	Natural or artificial fly, artificial minnow, or artificial crustacean, rodent, mollusc, creeper, huhu or matai grub.
