- (ii) Second hand machinery for installation or extraction by Dales Freightways Limited;
- (iii) Consignments which by reason of their dimensions are certified in writing by the New Zealand Railways Corporation as being over gauge for transport by rail. The certificate shall be carried with the consignment and produced to any Ministry of Transport Traffic Officer on demand:
