*CNG Fuel Systems Approval of Components for Experimental Purposes*

SCHEDULE

THE CNG variable regulator manufactured by Diesel Gas Ltd. of Lower Hutt to drawing No. DIS 002 or DG 001 and bearing the marking "DIS 002" when fitted to the 1983 Isuzu heavy goods service vehicle registered No. LF 3307.

Provided that all other components of the CNG fuel system fitted to the said vehicle are comprised of components approved for use in CNG fuel systems and are installed in accordance with the requirements of New Zealand Standard NZS 5422, Part 2, 1980.

This approval for experimental purposes shall be limited for the period up to and including 31 October 1984.
