Environmental Impact Report Notified: Waikato Coal-Fired Power Station

THE Commission for the Environment has received an Environmental Impact Report on the Ministry of Energy's proposal to build a coal-fired power station in the Waikato. The report will be audited by the Commission in accordance with the Environmental Protection and Enhancement Procedures.

Copies of this report can be obtained at a cost of \$20 from B. J. McGlinchy, Senior Power Development Engineer, Electricity Division, Ministry of Energy, Private Bag, Wellington.

Copies for public inspection are held at the following places: University libraries; the 4 main metropolitan public libraries; Hamilton, Huntly and Te Kauwhata public libraries; Huntly Borough, Raglan County and Franklin County Councils; Meremere and Tuakau Post Offices; and Waahi Marae.

Submissions on the environmental implications of the proposal are invited and should reach the Commission before 5 p.m. on Friday, 23 November 1984. Submissions should, where practicable, use A4-size paper and be typed, or hand-written in dark ink, and addressed to the Commissioner for the Environment, Commission for the Environment, P.O. Box 10-241, Wellington; or delivered to the Commission's offices at CPD House, 108 The Terrace, Wellington.

Submissions will be bound and published with the Commission's Audit.
