CLARIFICATION OF GUIDE TO GLOBAL IMPORT LICENCE TENDERING

There has been some confusion about the provision in the guidelines under paragraphs 45 to 47 for continuity licence and it is now obvious that the wording of paragraph 45 is not clear.

The intention of the continuity provision is to give successful tenders the right to take up in the following year an *entitlement* to up to 50 percent of the licence won in tendering in the previous year.

It is not intended to allow actual licence to be carried over into the second year. That is precluded under paragraph 48.
