PURSUANT to sections 15 and 16 of the Town and Country Planning Act 1977, the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Town and Country Planning (Wairarapa Regional Planning Scheme: Section One) Order 1983.

(2) This order shall come into force on the 20th day of February 1984.

2. Section one of Wairarapa Regional Planning Scheme approved—Section one of the Wairarapa Regional Planning Scheme as prepared in accordance with the Town and Country Planning Act 1977 by the Wairarapa United Council in 1983, and held in the office of the Commissioner of Works under reference number WAIR 7, is hereby approved.

3. Commencement of section one of the Wairarapa Regional Planning Scheme—Section one of the Wairarapa Regional Planning Scheme as approved by clause 2 of this order shall come into force on the 20th day of February 1984.
