production to the western boundary of Section 9, Block XII, Tutamoe Survey District; thence southerly along that western boundary and its production to the southern side of Karaka-Tutamoe Road:

Thence westerly along that southern side to the easternmost corner of Section 11, Block XI, Tutamoe Survey District; thence southwesterly along the south-eastern boundary of that Section 11, to its southernmost corner; thence north-westerly along the south-western boundaries of that Section 11 and Section 19, Block XI, Tutamoe Survey District, and Lot 1, D.P. 36334, to the south-western corner of that Lot 1; thence northerly along the eastern boundary of Section 5, Block X, Tutamoe Survey District, to the southern side of the Opouteke Stream, along a right line to the south-easternmost corner of Section 4, Block X, Tutamoe Survey District and along the eastern boundary of that Section 4, and Sections 15 and 12, Block VI, Tutamoe Survey District, and along the production of the lastmentioned boundary to the northern side of Haha Road; thence westerly and northerly along the northern and eastern sides of that road and north-easterly along the south-eastern sides of Tapuketaru Road to the road angle in Block III, Tutamoe Survey District, nearest the easternmost corner of Section 12A, Block II, Tutamoe Survey District; thence north-westerly along a right line to that easternmost corner and along the generally north-eastern boundaries of the said Section 12A to the eastern boundary of Section 4A, Block II, Tutamoe Survey District;

Thence northerly along that eastern boundary to the southern side of Waimatenui Road; thence easterly along that southern roadside to a point due south of the south-eastern corner of Section 1, Block II, Tutamoe Survey District, adjacent to the Mangakahia River; thence northerly along a right line to the said south-eastern corner; thence easterly along a right line between that corner and the southernmost corner of Section 6, Block XV, Punakitere Survey District, to the middle of the Mangakahia River, and down the middle of that river to a point in line with the western boundary of Section 3, Block XV, Punakitere Survey District; thence northerly to and along that western boundary, to the southern side of a legal road passing through that Section 3, along a right line to the northwesternmost corner of that Section 3; thence easterly along the morthern boundary of the said Section 3 and its production to the middle of the Mangaraupo Stream;

Thence south-easterly down the middle of that stream and the Mangakahia River to a point in Block III, Tutamoe Survey District, in line with the north-eastern boundary of Aukumeroa 2; thence south-easterly to and along that boundary and its production to the middle of the Mangakahia River and down the middle of that river to and northerly up the middle of the Awarua River to a point in Block IV, Tutamoe Survey District, in line with the southern boundary of the northern part of Nukutawhiti Block, shown on D.P. 9193; thence easterly to and along that southern boundary, parts of which now form the southern boundaries of Lots 1, 2, 3, 4, 5 and 6, D.P. 11394, to its easternmost point; thence north-westerly along the north-eastern boundary of Lot 1, D.P. 91882, to the middle of the Kaikou River; thence easterly down the middle of that river to and southerly up the middle of the Omapuku Stream to the south-western boundary of Kaikou A 3E; thence south-easterly along that boundary and its production to the middle of the Rotohanganui Stream in Block XIV, Motutau Survey District;

Thence north-easterly down the middle of that stream to a point in line with the south-eastern boundary of Kaikou A4A; thence north-easterly to and along that boundary and its production to the south-western corner of Moromaku Block; thence easterly and northerly along the southern and western boundaries of the said block, to the south-western corner of Motatau 2, No. 63 Block; thence easterly along the southern boundaries of that Motatau 2, No. 63, Motatau 2, No. 64A and 64B Blocks, shown on D.P. 9582, to the south-western boundary of Section 4, Block XII, Motatau Survey District; thence south-easterly along that boundary and northerly along the eastern boundary of that Section 4, to the south-western corner of Section 18, Block IX, Hukerenui Survey District; thence easterly along the southern boundary of that Section 18, and its production to the eastern side of Marlow Road; thence northerly generally along that eastern side to the south-western corner of Section 22, Block IX, Hukerenui Survey District;

Thence easterly along the southern boundary of Section 22 to the western boundary of Section 29, Block IX, Hukerenui Survey District; thence southerly along that western boundary to its southwestern point; thence easterly along the southern boundaries of that Section 29 and Sections 30 and 31, Block IX, Hukerenui Survey District, to the south-eastern corner of the last-mentioned Section 31; thence northerly and westerly along the eastern and northern boundaries of that Section 31 to the eastern side of a legal road forming the western boundary of Section 32, Block IX, Hukerenui Survey District; thence northerly along that eastern roadside and easterly along the southern side of Paiaka Road to a point in line with the western boundary of Section 51, Block X, Hukerenui Survey District; thence northerly to and along that boundary and easterly

along the northern boundary of that Section 51 to the south-western corner of Section 50, Block X, Hukerenui Survey District:

Thence northerly along the western boundaries of Sections 50 and 48, Block X, Hukerenui Survey District, to the southern side of Paiaka-Hukerenui Road, along a right line to the south-western corner of Section 61, Block X, Hukerenui Survey District and along the western boundary of that Section 61 to its north-western corner; thence easterly along the northern boundary of that Section 61 to the western side of Paiaka-Hukerenui Road, along a right line to the north-western corner of Lot 1, D.P. 67251 and along the northern boundaries of that Lot 1 and Section 38, Block X, Hukerenui Survey District to the western boundary of Section 9, Block X, Hukerenui Survey District; thence northerly along that boundary and its production to the northern side of State Highway No. 1;

Thence easterly along that northern roadside to the eastern boundary of an area of 5210 square metres (1 acre 1 rood 6 perches), shown as taken for road on S.O. Plan 10935; thence northerly along that eastern boundary and the eastern boundary of a legal road passing through Section 17, Block X, Hukerenui Survey District and its production to the middle of the Waipuakakahau Stream; thence southerly generally down the middle of that stream to and up the middle of the Waiotu River to a point in line with the northwestern boundary of Section 74, Block VI, Hukerenui Survey District; thence north-easterly to and along that boundary and its production to the eastern side of Tapuhi Road; thence northerly along that eastern roadside to the south-westernmost corner of Lot 3, D.P. 43284; thence easterly along the southern boundary of that Lot 3 to its south-easternmost corner; thence northerly along the eastern boundary of the said Lot 3 and the western boundaries of Sections 25 and 3, Block VII, Hukerenui Survey District, to the south-western corner of Section 2, Block VII, Hukerenui Survey District;

Thence easterly and northerly along the southern and eastern boundaries of that Section 2, to the south-eastern side of a legal road forming the generally eastern boundaries of Sections 9 and 10, Block III, Hukerenui Survey District; thence north-easterly along that roadside to that road angle nearest to the junction of the easternmost boundary of Section 10 with the northern side of the said road; thence northerly along a right line to the south-westernmost corner of Section 23, Block III, Hukerenui Survey District and along the eastern boundaries of Sections 10 and 24, Block III, Hukerenui Survey District, to the southern side of Parsons Road; thence easterly generally along that roadside to a point in line with the northern boundary of Section 11, Block IV, Hukerenui Survey District, to and along that boundary to the south-western corner of Section 3, Block IV, Hukerenui Survey District; thence northerly along the western boundary of Section 3, to the southern boundary of Paremata-Mokau A21; thence westerly along that southern boundary to the south-easternmost corner of Taumatahinau Block;

Thence northerly along the generally eastern boundary of that block to the southernmost corner of Section 5, Block XV, Russell Survey District; thence north-easterly along the south-eastern boundaries of that Section 5 and Section 2, Block XVI, Russell Survey District, to the southernmost corner of Waikare No. 17; thence northerly generally along the generally eastern boundary of that Waikare No. 17 and the generally western boundaries of part Tutaematai A, as shown on D.P. 27504, and part Tutaematai B 2 No. 3 Block, to the southern side of Russell Road in Block VII, Russell Survey District; thence due north to the northern side of that road; thence westerly along that northern side and northerly along the eastern side of that road and the western boundary of part Tutaematai B 2 No. 4, to its northernmost corner;

Thence south-easterly along the north-eastern boundary of that Tutaematai B 2 No. 4 and part Tutaematai B2 B2 Block, crossing the intervening Rawhiti Road, to the southernmost corner of Whangaroa-Ngaiotonga 4A1; thence north-easterly along the north-western boundaries of Whangaroa-Ngaiotonga 4G 3, 4G 4 and 4F 2, crossing the intervening Mahia Roadway and the Whangaruru North Road to the southern boundary of Whangaroa-Ngaiotonga 4A6D; thence easterly along that southern boundary to the point of commencement; together with all the islands known as the Hen and Chicken Islands (Taranga and Marotiri), the Poor Knights, and all other islands adjacent to the coastline of the county, and excluding therefrom the City of Whangarei, as hereinbefore described, and the Town District of Hikurangi, as described in New Zealand Gazette, 1908, page 1170.
