- (f) All prizes won in New Zealand are to be paid through the banking system in New Zealand in New Zealand currency.
- (g) Duty at the rate of 23.3 percent shall be payable to the New Zealand Government on all tickets sold to persons resident in New Zealand.
- (h) Every person who gives or disposes of or offers to give or dispose of any ticket in any Tattersall's lottery to any person in consideration of that person buying or having bought any goods or services or the right to attend any entertainment commits an offence and is liable on summary conviction to a fine not exceeding \$200.
- (i) A quarterly statement is to be submitted to the Department of Internal Affairs, giving the following details:
