Revoking Declaration of State Highway and Declaring Public Highway to be State Highway

PURSUANT to section 11 of the National Roads Act 1953, the National Roads Board, acting with the written approval of the Minister of Works and Development, hereby gives notice that the State highway described in the First Schedule below is revoked with effect from 31 March 1984, and that the public highway described in the Second Schedule below is declared to be State highway with effect from 1 April 1984, within the meaning and for the purpose of the National Roads Act.

FIRST SCHEDULE

ALL that portion of State Highway No. 3, that refers to Waitara, as described in Part II of the Schedule to the notice declaring public highways to be State highways published in the *Gazette*, 24 March 1960, No. 20, page 384.
