*The Traffic (Whangaroa County) Notice No. 1, 1984*

PURSUANT to the Transport Act 1962, and pursuant to a delegation from the Minister of Transport, and pursuant to a subdelegation from the Secretary for Transport, I, Carne Maurice Clissold, Chief Traffic Engineer, hereby give the following notice:

NOTICE

THIS notice may be cited as the Traffic (Whangaroa County) Notice No. 1, 1984.

The road specified in the First Schedule hereto is hereby declared to be a closely populated locality for the purposes of section 52 of the Transport Act 1962.

The road specified in the Second Schedule hereto is hereby declared to be a limited speed zone pursuant to regulation 21 (2) of the Traffic Regulations 1976\*.

The notice under the Transport Act 1949 dated the 18th day of May 1960†, which relates to roads situated within Whangaroa County at Kaero is hereby revoked.

FIRST SCHEDULE

SITUATED within Whangaroa County at Kaero: No. 10 State Highway (Pakaraka-Awanui via Mangonui): from a point 350 metres measured westerly, generally, along the said State Highway from its junction with Waikare Road to a point 140 metres measured easterly, generally, along the said State Highway from the said junction.

SECOND SCHEDULE

SITUATED within Whangaroa County at Kaero: No. 10 State Highway (Pakaraka-Awanui via Mangonui): from a point 140 metres measured easterly, generally, along the said State Highway from its junction with Waikare Road to a point 60 metres measured easterly, generally, along the said State Highway from its junction with Martins Road.
