ORDER IN COUNCIL

At the Government Buildings at Wellington this 7th day of May 1984.

THE HON. J. K. MCLAY PRESIDING IN COUNCIL

PURSUANT to section 7 of the National Parks Act 1980, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby declares that the land described in the Schedule hereto shall, as from the 14th day after the date of the publication of this Order in Council in the *Gazette*, be a national park subject to the National Parks Act 1980 and shall be added to and form part of the Tongariro National Park.
