EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice authorises the use of an Imperial weight (in addition to the equivalent metric weight) on the packages of certain goods sold by retail in New Zealand. It is a condition of the authority conferred by the notice that the denomination of the Imperial weight be not given greater prominence than the denomination of the metric weight.

The notice is the same as the Weights and Measures (Dual Denominations) Notice 1985 (S.R. 1985/75). That notice, which was expressed to come into force on the day after the date of its publication in the *Gazette*, was notified in the *Gazette* (*Gazette*, 1985, page 1672) but was not published.
