Auckland Harbour Bridge Authority Bylaw 1959, Amendment No. 18

PURSUANT to section 72 of the Transport Act 1962 and section 7 of the Auckland Harbour Bridge Authority Dissolution Act 1983, the National Roads Board hereby makes the following bylaw.

- 1. This bylaw may be cited as the Auckland Harbour Bridge Authority Bylaw 1959, Amendment No. 18.
- 2. This by law shall come into effect on the day after its publication in the ${\it Gazette}$.
- 3. The Auckland Harbour Bridge Authority Bylaw 1959 is hereby amended by adding, after clause 14, the following clause:
 - 14A (1) This clause shall apply to all heavy motor vehicles as defined in the Heavy Motor Vehicle Regulations 1974.
 - (2) No person shall operate a heavy motor vehicle on the extensions to the Auckland Harbour Bridge, being the extensions authorised by section 21A of the Auckland Harbour Bridge Act 1950.
- 4. Every person who commits an offence against this bylaw is liable on summary conviction to a fine not exceeding \$500 (five hundred dollars).
