- 3. This bylaw shall apply to all vehicles except heavy motor vehicles as defined in the Heavy Motor Vehicle Regulations 1974.
- 4. No vehicle at the intersection of State Highway No. 1 and Mungavin Avenue in the City of Porirua shall make the right turn from the northern leg of State Highway No. 1 onto Mungavin Avenue Railway Overbridge.
- 5. Every person who commits an offence against this bylaw is liable on summary conviction to a fine not exceeding \$200 (two hundred dollars).

This bylaw was made by resolution duly passed at a meeting of the National Roads Board held in Wellington on the 17th day of July 1985.
