

## ORDER

**1. Title**—This order may be cited as the New Zealand Society for the Intellectually Handicapped (Incorporated), Taranaki Branch Order 1985

**2. Exemption**—The New Zealand Society for the Intellectually Handicapped (Incorporated), Taranaki Branch an organisation approved\* under the former name of Intellectually Handicapped Children's Society (Incorporated), Taranaki Branch by the Minister of Labour under section 3 of the Disabled Persons Employment Act 1960, is hereby granted exemption in respect of its sheltered workshop at McLean Street, New Plymouth, Taranaki from—

(a) All the provisions of every award and agreement that would otherwise apply to persons employed in that workshop; and

(b) The minimum Wage Act 1945, the Holidays Act 1981, and sections 10 (2) (b) and 15 of the Factories and Commercial Premises Act 1981.
