

Maraehara River; thence generally south-westerly up the middle of that River to a point in line with the western boundary of Pukerangiara 2B; thence northerly to and along that boundary to the south-western boundary of part Marangairoa 2E1; thence north-westerly along the south-western boundary of part Marangairoa 2E1 to the easternmost corner of Pariwhero B; thence generally south-westerly along the south-eastern boundary of Pariwhero B and its production to the middle of the Te Puni Stream, down the middle of that stream to its confluence with the Maraehara River, up the middle of the Maraehara River to a point in line with the south-western boundary of Whakaangi A3; thence north-westerly to and along the south-western boundary of Whakaangi A3 to the south-eastern boundary of Whakaangi A2; thence south-westerly along the south-eastern boundary of Whakaangi A2 and the south-eastern boundaries of Lots 3 and 4, D.P. 3251 to the north-eastern boundary of Lot 4, D.P. 2745; thence north-westerly, south-westerly and south-easterly along the north-eastern, north-western and south-western boundaries of Lot 4, D.P. 2745 and the production of the last-mentioned boundary to the middle of the Maraehara River; thence generally north-easterly down the middle of that river to its confluence with the Otuturangi Stream; thence generally southerly up the middle of the Otuturangi Stream to and along the north-eastern and south-eastern boundaries of Wharikiraponga 3B and the eastern boundary of Tauwharerata B2 to the south-eastern corner of Lot 2, D.P. 6364; thence generally westerly along the generally southern boundaries of Lots 2 and 1, D.P. 6364, the southern and western boundaries of Tauwharerata A2, the northern boundary of Section 1, Block VII, Mangaoparo Survey District, the eastern boundary of Section 3, Block VI, Mangaoparo Survey District and the production of the last-mentioned boundary to the middle of the Taurangakautuku River, up the middle of that river to the south-eastern boundary of Section 2, Block II, Mangaoparo Survey District, along the south-eastern boundaries of Sections 2 and 5, Block II, Mangaoparo Survey District, the generally south-western boundaries of Sections 5 and 2 aforesaid, the northern boundary of part Waiorongomai and the northern boundary of Section 3, Block VIII, Raukumara East Survey District to Trig. Station Pakira; thence south-westerly along the south-eastern boundary of Te Kumi 1 to Trig. Station 1328, Whanokao; thence northerly along the south-western and western boundaries of Te Kumi 1 to Trig. Station 1323, Kaikoura; thence easterly along the southern boundaries of Pohueroro 6B, 6A and 5A and the production of the last-mentioned boundary to the middle of the Raukokore River; thence generally northerly down the middle of the Raukokore River to its confluence with the Waikura River, up the middle of the Waikura River to its confluence with the Mangahinatore Stream, up the middle of the Mangahinatore Stream to its confluence with the Whekeiro Stream, up the middle of the Whekeiro Stream to a point in line with the generally western boundary of Lot 2, D.P. 10599 AK situated in Block VI, Whangaparaoa Survey District, to and along that boundary and the generally western boundary of Lot 1, D.P. 10599 AK to Trig. Station G3, Tapuaeharuru; thence easterly along the northern boundary of Lot 1, D.P. 10599 AK and its production to the middle of the Mangapouri Stream, down the middle of the Mangapouri Stream to its confluence with the Whangaparaoa River, down the middle of the Whangaparaoa River to a point in line with the southern boundary of part Whangaparaoa 2D and 2E2B2, to and along that boundary and the southern boundary of Section 1, Block I, Matakaoa West Survey District to the south-eastern corner of the said Section 1; thence northerly along the eastern boundary of Section 1 aforesaid and its production to and along the western boundary of part Wharekahika A2 and its production across a legal road to and along the western boundary of Wharekahika A1 and its production across State Highway No. 2 to and along the last-mentioned boundary to the point of commencement.

Station 1323, Kaikoura; thence southerly along the western and south-western boundaries of Te Kumi 1 to Trig. Station 1328, Whanokao; thence south-westerly along a right line between Trig. Station 1328, Whanokao and Trig. Station Kapua situated in Block V, Hikurangi Survey District to a point on the southern boundary of Puketauhinu 1B; thence westerly along the southern boundary of Puketauhinu 1B to a point in the middle of the Mangatutara Stream, generally westerly down the middle of that stream to its confluence with the Motu River; thence generally north-westerly down the middle of the Motu River to a point in line with the south-eastern boundary of Lot 6, D.P. 3116 situated in Block XIV, Haparapara Survey District; thence south-westerly to and along that south-eastern boundary and the south-eastern and southern boundaries of Lot 5, D.P. 3116 to the southernmost corner of that Lot 5; thence north-westerly along the south-western boundaries of Lot 5 and Lot 2, D.P. 3116 to Trig. Station Pukepapa; thence westerly along the northern boundary of part Lot 1, D.P. 3116 to the south-eastern corner of part Maraenui 9; thence north-westerly along the north-eastern boundary of part Maraenui 9 and its production across State Highway No. 35 to and along the north-eastern boundaries of Section 9, Block II, Tokata Survey District and part Maraenui 9 to the sea coast; thence generally north-easterly along the sea coast crossing the mouths of all harbours and inlets to the point of commencement. Special Arrangements for the Provision of Medical Services for the Residents of Te Kaha and Surrounding District
