### *State Forest Land Set Apart as State Forest Park for Addition to Taranua State Forest Park—Wellington Conservancy*

#### A PROCLAMATION

PURSUANT to section 63B (1) of the Forests Act 1949 (as substituted by section 19 of the Forests Amendment Act 1976), I, The Honourable Sir David Stuart Beattie, the Governor-General of New Zealand, hereby set apart the State forest land described in the Schedule hereto as State forest park which shall hereby form part of the Taranua State Forest Park.

#### ORDER IN COUNCIL

At the Government House at Wellington this 26th day of August 1985

PURSUANT to section 149 of the Rating Act 1967, His Excellency the Governor-General acting by and with the advice and consent of the Executive Council, hereby exempts the Maori freehold land described in the Schedule hereto from the liability for the payment of rates.
