THE Meat Export Prices Committee, after having consulted with the Minister of Agriculture and pursuant to sections 13 and 14 (1) of the Meat Export Prices Act 1976, hereby gives notice that it has determined that the bench mark grades, and the minimum and trigger prices for these grades of meat intended for export for the 1985/86 season, commencing on 1 October 1985, shall be as follows:
