

TARIFF INDUSTRY ASSISTANCE (DECISION) NOTICE NO. 1985/32
Decisions of the Minister of Customs in respect of Part I and Part II of the Customs Tariff

- 1 Notice is hereby given that the following decisions have been made in respect of the goods published in the Schedules to this notice.
- 2 SCHEDULE 3 - Limited Decisions
