omata River thence along a ridge top being the water shed boundary between Skerrets Creek, Nikau Creek and Turere Stream thence along another ridge top being the water shed boundary between George Creek, Whakanui Creek and Big Huia Creek to a point where that ridge top meets the junction of Big Huia Creek and North Boulder Creek thence up the last mentioned Creek for a distance of approximately 500 metres to a point opposite a ridge top forming the southern water shed of North Boulder Creek thence along that ridge top to Papatahi Trigonometrical Station, Block III, Onoke Survey District.

Thence generally south-westerly along the southern boundary of Section 95 and its projection across an unnamed road thence along the eastern and western boundaries of Lot 99, D.P. 672 to the southern eastern corner of part Lot 3, D.P. 4269, thence along the southern boundaries of the said part Lot 3 and part Lot 2, D.P. 4269 and the projection of that line to the western side of Paekakariki Hill Road thence northerly along the western side of that road to the north-eastern corner of part Lot 1, D.P. 4268, thence westerly along the northern boundary of the said part Lot 1 and its projection to eastern side of State Highway 1, thence south-westerly along the eastern side of that Highway to a point where it meets the eastern boundary of that part of the Wellington Fire District described in the First Schedule of the New Zealand Gazette, dated 20 October 1983, page 3476.

Thence generally south along that boundary to the point where it meets the mean high water at Porirua Harbour thence around the high water being the eastern boundary of Porirua Harbour to a point where it meets that part of the Wellington Fire District described in the Second Schedule of the New Zealand Gazette, dated 20 October 1983, page 3476, thence along that boundary to the point of commencement.
