NOTICE

1. Title and commencement—(1) This notice may be cited as the Local Government Training Board Notice 1982, Amendment No. 2 and shall be read together with and deemed part of the Local Government Training Board Notice 1982 (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the 14th day after its notification in the *Gazette*.

2. Clause 2 amended: Clause 2 (a) of the principal notice is hereby amended;

(a) By omitting paragraph (2) and substituting the following paragraph.

“(2) One member appointed by the Municipal Association of New Zealand (Inc.) who shall be an elected member of a borough council, city council, district council, town council, united council or regional council”.

(b) By omitting paragraph (3) and substituting the following paragraph.

(3) One member appointed by the New Zealand Counties Association (Inc.) who shall be an elected member of a county council, district council, united council or regional council.

(c) By omitting paragraph (9) and substituting the following paragraph.

(9) One member appointed by the New Zealand Catchment Authorities Association who shall be an elected member of a regional water board, catchment board, catchment commission or the Waikato Valley Authority.
