PURSUANT to sections 15 and 16 of the Town and Country Planning Act 1977, the Governor-General, acting by and with the consent of the Executive Council, hereby makes the following Order:

ORDER

**1. Title and commencement**—(1) This Order may be cited as the Town and Country Planning (Tongariro Regional Planning Scheme: Section One) Order 1985.

(2) This Order shall come into force on the 1st day of March 1985.

**2. Section 1 of the Tongariro Regional Planning Scheme approval**—Section 1 of the Tongariro Regional Planning Scheme as prepared in accordance with the provisions of the Town and Country Planning Act 1977 by the Tongariro United Council in 1984, and held in the office of the Commissioner of Works under reference No. TON 23, is hereby approved.

**3. Commencement of Section 1 of the Tongariro Regional Planning Scheme**—Section 1 of the Tongariro Regional Planning Scheme as approved by clause 2 of this Order shall come into force on the 1st day of March 1985.
