

10. At the expiry or cancellation of this licence, the Electrical Supply Authority shall as required by notice in writing by the Minister of Energy remove all buildings, poles and other erections and all transmission lines, plant and other machinery and other removable equipment authorised by the licence to be erected, installed or provided and if within 12 months after being so required the Electrical Supply Authority fails or neglects to remove the same, then the same shall, without payment of any compensation vest in and become the property of the Crown and it shall be lawful for any person authorised by the Minister of Energy in that behalf, subject to compliance with section 15A, Electricity Act 1968 to enter upon any land or premises and take possession of and remove the same or any part thereof.

11. Nothing contained in the licence, either expressly or by implication shall be deemed to authorise the Electrical Supply Authority to erect, construct or maintain any lines or works except subject to conditions (not inconsistent with this licence) as may from time to time be lawfully imposed by any local authority within the district of which any such lines or works may be situated.

12. The systems of supply shall be as described in paragraphs (a), (b), (c), (d), (e), (f), and (h) of regulation 13 of the Electrical Supply Regulations 1984.

13. The Electrical Supply Authority shall, 6 months prior to the expiry of the term of this licence provided in clause 7 herein, make written application to the Minister of Energy for the granting of a new licence.

SCHEDULE

AREA OF SUPPLY

ALL that area in the Canterbury Land District bounded by a line commencing at the mouth of the Waimakariri River, Block IV, Christchurch S.D. and proceeding generally north-westerly along the middle of that river to a point in line with the north-eastern boundary of Rural Section 14216; thence south-easterly to and along that boundary, the north-eastern boundary of Rural Section 17167 and the production of the last-mentioned boundary to the left (western) bank of the Styx River; thence southerly generally along that bank to a point in line with the northernmost corner of part Lot 3, D.P. 9363 (comprised in certificate of title 12F/259); thence westerly to and along the northern boundary of that part lot and the generally northern boundary of Reserve 1835 to the eastern boundary of part Rural Section 18057 (comprised in certificate of title 539/16); thence southerly and westerly along the eastern and southern boundaries of that section to the south eastern boundary of part Reserve 1250; thence south-westerly along that boundary to a point in line with the southern boundary of part Lot 2, D.P. 11676 (comprised in certificate of title 11A/1025); thence westerly to and along that boundary and its production to the middle of a watercourse (being the old bed of the Waimakariri River); thence generally westerly along the middle of that watercourse to a point in line with the middle of Shipleys Road, Block VI, Christchurch S.D.; thence south-westerly to and along the middle of Shipleys Road, Johns Road and Russley Road to the middle of Yaldhurst Road; thence south-easterly generally along the middle lines of Yaldhurst Road, Riccarton Road, Hansons Lane, Blenheim Road and Annex Road and the middle line of Annex Road produced to the middle of Wigram Road, then south-westerly along the middle of that road to the middle of Halswell Junction Road; thence north-westerly along that road to a point in line with the south-eastern boundary of Lot 2, D.P. 3256, Block XIV, Christchurch S.D.; thence south-westerly to and along that boundary and its production to the middle of Knights Stream; thence south-easterly generally along the middle of that stream and the Halswell River to a point in line with the southern boundary of part Rural Section 1593; thence south-easterly to and along that boundary and the southern boundaries of Rural Sections 772, 1594, 1100, 1913 and 1592 to and south-westerly along the north-western boundary of part Lot 1, D.P. 43283 to the south-western boundary of said part Lot 1; thence south-easterly along the south-western boundaries of said part Lot 1 and Lot 1, D.P. 16613 and Lot 1, D.P. 19174 to the westernmost corner of Lot 3, D.P. 43283; thence north-easterly along the north-western boundaries of said Lot 3 and part Lot 1, D.P. 22535 and the last mentioned boundary produced to the middle of Kennedys Bush Road; thence generally south-easterly along the middle of said road to a point in line with the generally northern boundary of part Rural Section 33743X; thence south-easterly to and along that boundary to the northern side of the Summit Road; thence easterly and northerly along the northern and western sides of said road to the southern most corner of Lot 4, D.P. 18411; thence along the south-western boundary of said Lot 4 and the south-western and north-western boundary of Lot 1, D.P. 18411 and the last-mentioned boundary produced to and along the north-eastern side of Worsleys Road to the middle of the Cashmere Stream; thence generally northerly along the middle of that stream and its production to the left bank of the Heathcote River; thence north-easterly and southerly along that left bank to a point in line with the northern boundary of Lot 37, D.P. 15560; thence westerly, across Sloan Terrace, to and along the northern boundary of said Lot and Reserve 4635 to the eastern side

of Remuera Avenue; thence along a right line across said Avenue to the easternmost corner of Lot 16, D.P. 16699; thence along the north-eastern boundaries of said Lot 16 and Lots 5, 4 and 1, D.P. 15560 and the last-mentioned boundary produced to the middle of Centaurus Road; thence south-easterly along the middle of that road to Standard Stone 391, thence due north to the left bank of the Heathcote River; thence north-easterly generally along that bank to a point in line with the north-eastern boundary of part Rural Section 2115; thence south-easterly to and along that boundary to and easterly along the northern boundary of Rural Section 2135 to the western side of Huntsbury Avenue; thence south-westerly along the eastern boundary of Rural Section 2135 and Rural Section 34655 to the western side of Huntsbury Avenue; thence southerly along the western side of said road to and westerly and southerly along the western side of the Summit Road to the summit of the Port Hills; thence north-easterly along the summit of the Port Hills to a point in line with the western boundary of Rural Section 23560; thence northerly to and along that boundary and northerly along the western boundaries of Rural Sections 23594, 104 and 966 to the southern side of the Port Hills Road; thence easterly along that side of said road and its production to the eastern side of Scruttons Road; thence northerly along the eastern side of said road to the north-west corner of Rural Section 329; thence along the north-west boundary of said Section and its production to the left bank of the Heathcote River; thence southerly and northerly along said left bank to a point at a bearing of 265°9' and 137.10 metres from the southernmost corner of part Rural Section 4 (comprised in certificate of title 369/2); thence along that line to the aforementioned corner of part Rural Section 4; thence southerly along a right line to the northernmost corner of Lot 1, D.P. 15310; thence in a southerly direction along the eastern side of Ferrymead Terrace and Bridle Path Road to the north-western corner of Lot 1, D.P. 14137; thence easterly along the northern boundary of said Lot 1 and the northern boundary of Lot 1, D.P. 20951 to and south-westerly along the north-western boundaries of Lots 1, 2, 3, 4, 5 and 6, D.P. 17501 to the south-western corner of said Lot 6; thence south-easterly along a right line to a point on the north-east side of the Summit Road being at a bearing of 288°55' and a distance of 37.94 metres from the westernmost corner of Lot 1, D.P. 11350, thence easterly along the northern side of the Summit Road to a point in line with the east-ern side of Broadleaf Lane; thence south-easterly to and along the eastern side of said lane to the northern boundary of Rural Section 36956 (Closed Road); thence south-easterly along the northern boundary of said Section 36956 and Rural Section 24077Y to a point in line with the south-eastern boundary of part Lot 2, D.P. 11832 (*New Zealand Gazette*, 1964, page 1117); thence south-westerly to and along that boundary to a point on a line bearing 86°11' from Trig. Station Mount Pleasant; thence easterly along that bearing to the south-western boundary of Rural Section 24077Y (Closed Road); thence south-easterly along said boundary, southerly along the western boundary of Rural Section 500X (Closed Road) and the southern boundary of Rural Section 33906X to the north-eastern corner of Rural Section 33906X; thence generally north-easterly along a track passing through Rural Section 205 to Evans Pass; thence due east across the Lyttelton-Sumner Road to and north-westerly along that road side to the south-eastern boundary of Rural Section 36825 (Closed Road); thence north-easterly along the south-eastern boundaries of said Rural Section 36825 and Rural Sections 36826 (Closed Road) and 36827 (Closed Road) to a point due north of Trig. Station MM; thence southerly along a line passing through Trig. Station MM to the mean high watermark of the Lyttelton Harbour; thence north-easterly along said high water mark to Godley Head, thence generally northerly along the sea coast to the mouth of Waimakariri River, being the point of commencement.

Excluding the area of supply of the Riccarton Borough Council as described below:

All that area in the Canterbury Land District bounded by a line commencing at the middle line of Blenheim Road in line with the centre line of Wharenui Road and proceeding north-westerly to and along Wharenui Road to the middle of Riccarton Road; thence easterly along the middle of that road to a point in line with the middle of Clyde Road; thence north-easterly to and along the middle of Clyde Road to the middle of the Avon River; thence generally north-easterly and easterly along the middle of said river to a point in line with the south-eastern boundary of Lot 321, D.P. 6079; thence south-westerly to and along that boundary and the south-eastern boundaries of Lots 320 and 319 of D.P. 6079 and the last-mentioned boundary produced to the south-western side of Totara Street; thence south-easterly along said side to the north-western corner of Lot 389, D.P. 6500; thence generally southerly along the western boundaries of said Lot 389 and Lots 388, 387, 386, 385, 384, 383 and 382, D.P. 6500 and Lots 1, 2, and 3, D.P. 6918 to the north-western side of Hinau Street; thence along a right line across Hinau Street to the north-western corner of Lot 316, D.P. 6079; thence along the south-western boundary of said Lot 316, to and along the southern boundary of Lot 2, D.P. 26376 to and southerly along the eastern boundaries of Lots 314, 313 and 312, D.P. 6079 and Lots 2 and 1, D.P. 45558 to the north-western side of Totara Street; southerly along said side to the eastern side of Puriri Street, southerly along said eastern side to the south-eastern side of Totara Street,
