PURSUANT to the Commerce Act 1975, I, Wayne Eric Scanlan, pursuant to a delegation from the Secretary of Trade and Industry, hereby make the following price order:

- 1. This order may be cited as Price Order No. 301 and shall come into force on the 21st day of January 1985.
- 2. (1) Special Approval No. S. 322\* is hereby revoked.
- (2) The revocation of the said order shall not affect the liability of any person for any offence in relation thereto committed before the coming into force of this order.
- 3. References in this order to metropolitan areas are references to the metropolitan areas described in the Schedule hereto.

## APPLICATION OF THIS ORDER

4. This order applies with respect to all Spanish navel oranges sold by way of retail in New Zealand.

# MAXIMUM RETAIL PRICES OF SPANISH NAVEL ORANGES

- 5. (1) The maximum price that may be charged or received by any retailer for any Spanish navel oranges to which this order applies shall be:
- (a) When sold by a retailer carrying on business in any of the metropolitan areas of Auckland, Wellington, Christchurch, or Dunedin, or in any of the Cities or Boroughs of Whangarei, Hamilton, Tauranga, Rotorua, Gisborne, New Plymouth, Stratford, Hawera, Wanganui, Palmerston North, Napier, Hastings, Masterton, Blenheim, Nelson, Greymouth, Timaru, Westport, Oamaru, Balclutha, Gore, Alexandra, or Invercargill— Alexandra, or Invercargill-

\$2.62 a kilogram.

(b) When sold by a retailer carrying on business elsewhere— \$2.64 a kilogram.

(2) If in respect of any lot of oranges the price calculated in accordance with the foregoing provisions of this clause is not an exact number of cents, the maximum price of the lot may be computed to the nearest whole cent.

#### PROVISIONS FOR SPECIAL PRICES

6. Notwithstanding anything to the contrary in the foregoing provisions of this order, and subject to such conditions, if any, as he thinks fit, the Secretary, on application by any retailer, may authorise special maximum prices in respect of any Spanish navel oranges to which this order applies where special circumstances exist, or for any reason extraordinary charges (freight or otherwise) are incurred by the retailer. Any authority given by the Secretary under this clause may apply with respect to a specified lot or consignment of oranges, or may relate generally to all Spanish navel oranges to which this order applies sold by the retailer while approval remains in force. in force.
