

PURSUANT to the Import Control Regulations 1973 (S.R. 1980/246) the Secretary of Trade and Industry, acting under delegated authority is calling tenders for the goods specified below. Tenders close on 27 May 1985 at 5 p.m. and must be received by the Registrar of Tenders by then to be valid.

Instructions for tenderers and the general terms and conditions which apply to the submission and acceptance of tenders are set out in the Guide to Licence Tendering dated November 1984. Tenders should be addressed to the Registrar of Tenders, P.O. Box 3146, Wellington, or be delivered by hand to the First Floor of the Bowen State Building, Wellington. Tenders for Round 24 should reach the Registrar no later than 5 p.m. on 27 May 1985.

NOTE:

1. Tenderers should refer to the Customs Tariff and the Import Licensing Schedule for a definitive description of the goods included in the list above.

2. Tenderers should be conversant with the various statutes and regulations which importing enterprises are obliged to comply with, such as the Food and Drug Regulations 1973, Safety Standards, Duties and Sales Tax, etc., where relevant.

3. Bids may be sent in one envelope. The envelope must be marked Import Licence Tender.

4. Where two or more item codes are tendered under a single tender number, successful tenderers should nominate which item code(s) the licence(s) should be issued under when payment is made.
