(2) Price Order Number 293\*, issued by the Secretary of Trade and Industry, is hereby amended as resolved by the Commission in Decision No. 117, dated 14 March 1985.

2. In this order, unless the context otherwise requires:

- "The Act" means the Milk Act 1967: "Milk" has the same meaning as in the Act but does not include cream or goats' milk:
- "Milk district" means a milk district constituted and declared as a milk district under the Act:
- "Standard rates" means the standard rates of margins and allowances payable in respect of the treatment of town milk specified in the Schedule hereto: "Treatment" has the same meaning as in the Act, but does not
- include refrigeration in a storage depot elsewhere than at the treatment station or the service of homogenisation by a
- treatment station: "Treatment station" means any plant or premises for the treatment of milk operated pursuant to the Act.

3. This price order applies to all milk sold for human consumption in any milk district after the coming into force of this price order.

4. The standard rates specified in the Schedule hereto are hereby fixed with effect from and including the 1st day of March 1984.
