Clause 58.3 Covering

Omit the charge of \$6.40 per tarpaulin in the third line of this clause and substitute \$7.00.

59. PRIVATE SIDING TRAFFIC: HAULAGE, HANDLING AND TALLYING CHARGES AND WAGON MINIMA

Clause 59.5.1 Haulage Charge

Omit the charge of \$15.89 per tonne for goods and \$12.24 per cubic metre for timber and substitute \$17.00 and \$13.00. Omit the minimum charges of \$80.00 per 4-wheeled wagon and \$160.00 per bogie wagon and substitute \$85.00 and \$170.00.

Clause 59.5.2 Handling

Omit the charges of \$8.90 per tonne for goods and \$18.50 per cubic metre for timber and substitute \$9.50 and \$19.50. Omit the minimum charges of \$3.20 and \$9.25 and substitute "as for one tonne" and "as for one cubic metre" respectively.

Clause 59.5.3 Tallying

Omit the charge of \$3.55 per tonne and the minimum charge of \$3.55 and substitute \$4.00 in each case.

60. WEIGHING

Clause 60.2.1 Goods weighed in Railway wagons

Omit the charges of \$4.15 and \$8.30 and substitute \$4.50 and \$9.00.

Clause 60.2.2 Multiple weight certificates

Omit the charge of \$1.59 for additional copies of weight certificates and substitute \$3.00.

Clause 60.2.3 Other goods weighed

Omit the charges of \$1.60 per bale for wool and skins, \$0.80 for skins in bundles and \$1.60 per 100 kilograms for other goods and substitute \$2.00, \$1.00, \$2.00. Omit the present minimum charge of \$0.80 per package and substitute \$1.00.

61. CRANAGE

Clause 61.1 Charges

Omit the charges of \$27.80 per tonne for goods not received or to be despatched by rail and substitute \$30.00.

Omit the charge of \$5.60 per tonne for articles exceeding 1.5 tonnes and substitute \$6.00.

Clause 61.3.1 Capacity up to three tonnes

Omit the charge of \$46.00 and substitute \$50.00.

Clause 61.3.2. Capacity three to six tonnes

Omit the charge of \$55.00 and substitute \$60.00.

Clause 61.3.3 Capacity over six tonnes

Omit the charge of \$69.00 and substitute \$75.00.

62. STORAGE

Clause 62.4.1 Omit the charge of \$1.32 per cubic metre and \$23.87 maximum charge per container up to 3.048 m in length and substitute \$1.50 and \$25.00.

Omit the charge of \$47.75 per container or seafreighter exceeding 3.048 m but not exceeding 6.096 m and substitute \$50.00.

Omit the charge of \$95.50 per container exceeding 6.096 m and substitute \$100.00.

Clause 62.5.1 Charges

Omit the charge of \$3.20 per tonne and the minimum charge of \$1.60 and substitute \$4.00 and \$2.00.

Clause 62.5.2 Goods stored in open

Omit the minimum charge of \$1.60 and the tarpaulin charge of \$4.76 and substitute \$2.00 and \$5.00.
