The Standards Act 1965—Draft New Zealand Standard Specifications Available for Comment

PURSUANT to subsection (3) of section 23 of the Standards Act 1965, notice is hereby given that the following draft New Zealand standard specifications are being circulated.

Number and Title of Specification

DZ 5441 Lighting and retroreflectors for pedal cycles.

Ministry of Transport and DSIR studies show that poor conspicuity of pedal cycles is a significant factor in many accidents with motor vehicles and some cycle lights and retroreflectors available for purchase are inadequate.

This draft Standard addresses two major aspects: the performance of the lights and retroreflectors as manufactured items and the correct arrangement and fitting to achieve the required conspicuity.
