ORDER IN COUNCIL

At the Government House at Wellington this 25th day of November 1985

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 165 of the Harbours Act 1950, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Tomahawk Beach Foreshore Control Order 1985.

(2) This order shall come into force on the 1st day of December 1985.

2. Interpretation—In this order—

“The Act” means the Harbours Act 1950;

“The Council” means the Dunedin City Council constituted under the Local Government Act 1974;

“Foreshore” means such parts of the bed, shore, or banks of a tidal water as are covered and uncovered by the flow and ebb of the tide at ordinary spring tides.

A PROCLAMATION

PURSUANT to section 63B (1) of the Forests Act 1949 (as substituted by section 19 of the Forests Amendment Act 1976), I, The Most Reverend Sir Paul Alfred Reeves, the Governor-General of New Zealand, hereby set apart the State forest land described in the Schedule hereto as State forest park, which shall hereby form part of the Kaimai - Mamaku State Forest Park.
